

AMP CAPITAL SHOPPING CENTRES UNLEASH YOUR EXPLORER PROMOTION

CONDITIONS OF ENTRY

1. Information on how to enter, mechanics of entry and prize form part of these Conditions of Entry. Entry into the promotion is deemed acceptance of these Conditions of Entry. Entry is via Internet only either at each participating AMP Capital Shopping Centre's website or on Instagram or Facebook.

PROMOTIONAL PERIOD

2. The promotion commences at 9:00am (AEST) on **07/08/2017** and ends at 9:00pm (AEST) on **31/08/2017 (Promotional Period)**.

ELIGIBILITY

3. Entry is only open to residents of Australia and New Zealand (excluding ACT and SA residents) aged 18 years or older who, in the event they are the winner, are able to travel to and remain in Broadbeach, Queensland, Australia for two (2) nights during the period 07/09/2017 – 06/09/2018 in order to participate in the prize in accordance with Conditions 16 - 20 (**Entrants**).
4. WINNER DETERMINATION
