

“AMP CAPITAL- Ignite your Senses” Chopping Board Gift PROMOTION
TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is AMP Capital Shopping Centres Pty Limited (ABN 13 001 595 955) of 50 Bridge Street, Sydney, NSW 2000, telephone (02) 9257 1900 (“**Promoter**”).
3. Entry is only open to Australian residents.
